DESIGN FOR TYPE.

SPECIFICATION forming part of Design No. 16,716, dated June 1, 1886.

Application filed April 29, 1886. Serial No. 200,631. Term of patent 7 years.

To all whom it may concern:

Be it known that I, WILLIAM W. JACKSON, (assignor to the MACKELLAR, SMITHS & JORDAN COMPANY,) of the city and county of Philadelphia, Pennsylvania, have invented and produced a new and original Design for a Font of Printing-Type, of which the following is a specification.

The nature of my design is clearly shown in the accompanying typographic impression, to which reference is made; and it consists of an unshaded ornamental letter having the heavy dot termination.

The left-hand portion of the A, M, and N consists of the curved line with heavy dot termination. The right-hand portion of the H, K, V, W, and Y consists of the curved line with heavy dot termination. The upper rounding portion of the B, D, P, and R is extended above the up-and-down portion, and has the heavy dot termination. The C, E, F, G, L, X, and Z have the heavy dot termination upon the right of the letter. In the O and Q a space is left between the rounding portion of the letter and the heavy dot termination. The lower rounding portion of the B crosses the up-and-down portion of the letter and has the heavy dot termination. The face of the E, upon the right, is crossed by the curved line with the heavy dot termination. The B, F, P, R, and S are extended below the line. The up-and-down portion of the A, M, and R, upon the right, is slightly concaved at its base, and this characteristic is found in the rest of the letters of the font except the C, E, G, J, O, Q,

and Z, either at the top or bottom of the up-and-down portions.

Having now described my invention, I claim as new—

The design for a font of printing type, as shown, the same consisting of an unshaded ornamental letter having the heavy dot termination, the left-hand portion of the A, M, and N consisting of the curved line with heavy dot termination, the right-hand portion of the H, K, V, W, and Y consisting of the curved line with heavy dot termination, the upper rounding portion of the B, D, P, and R extended above the up-and-down portion and having the heavy dot termination, the C, E, F, G, L, X, and Z having the heavy dot termination upon the right of the letter, in the O and Q a space left between the rounding portions of the letter and those portions having the heavy dot termination, the lower rounding portion of the B crossing the up-and-down portion and having the heavy dot termination, the face of the E, upon the right, crossed by the curved line with heavy dot termination, the B, F, P, R, and S extended below the line, the up-and-down portion of the A, M, and R, upon the right, slightly concaved at its base, and this characteristic is found in the rest of the letters of the font except the C, E, G, J, O, Q, and Z, either at the top or bottom of the up-and-down portions.
